CU INC. ANNOUNCES DEBENTURE ISSUES

CALGARY, Alberta -- CU Inc. announced today that it will issue \$200,000,000 of 5.580% Debentures maturing on May 26, 2038, at a price of \$100.00 to yield 5.580% and \$125,000,000 of 5.563% Debentures maturing on May 26, 2028, at a price of \$100.00 to yield 5.563%. These issues were sold by BMO Nesbitt Burns Inc., RBC Dominion Securities Inc. and TD Securities Inc. Proceeds from the issues will be used to finance capital expenditures, to repay existing indebtedness, and for other general corporate purposes of ATCO Electric Ltd. and ATCO Gas and Pipelines Ltd.

CU Inc. is a wholly owned subsidiary of Canadian Utilities Limited, part of the ATCO Group of companies. CU Inc. is an Alberta based corporation with assets of approximately \$4.9 billion and more than 3,700 employees and is comprised of two main business segments: Utilities (natural gas and electricity transmission and distribution) and Power Generation.
